






## Call for papers – the XII conference of the Nordic Association for Semiotic Studies

#### "MEANING IN PERCEPTION AND THE SENSES"

Vilnius University, 5-7 November, 2021

**THE XII NASS CONFERENCE** will be hosted by the Algirdas Julius Greimas Centre for Semiotics and Literary Theory at the Faculty of Philology of Vilnius University in Vilnius, Lithuania.

The conference addresses perception and the senses. Perception and the senses are, for all sentient species, the gateway to the environment and to other organisms and individuals. As such, they are instrumental in comprehending and constructing the world as experienced and lived, and in many respects indistinguishable from semiosis and meaning. This makes their study in semiotics a necessary task.

As a constitutive element of experience and signification, perception and the senses are also an important element in media, cultures, worldviews and histories. Perception and the senses can be construed as a pliable conductor for intermediality, for our imaginaries, and for our bonds to environments and other sentient and sensitive beings as well as ourselves.

This conference focuses on how theories of meaning are positioned vis-à-vis perception and senses. We welcome papers investigating the relations between perception and the senses and a broad range of semiotic concepts – from representation and semiosis to language, signification, modalities and modelling.

**ABSTRACTS** are to be submitted in Word files to **nassxiivilnius@gmail.com** with the subject line "Abstract for NASS XII". Your abstract submission should contain your (1) full name; (2) affiliation; (3) e-mail address; (4) paper title; (5) paper abstract, up to 500 words; (6) 3–5 keywords; (7) short bionote of up to 100 words.

The deadline for abstract submission is 15 June, 2021.

Notifications of acceptance will be sent out by 1 August, 2021.

#### REGISTRATION AND CONFERENCE FEE

While hoping for the best possible outcomes of the ongoing vaccination, we will be preparing for the likely restrictions and limitations that participants might face. For the time being, all such matters are to be decided ad hoc in due time.

In order to register for NASS XII, payment of a conference fee is required.

The early bird registration fee is 90€; the deadline for early bird registration is 1 September, 2021.

The late registration fee is 110€, and the deadline is 15 October, 2021.

The fee covers attendance, coffee breaks, lunch, and a conference program booklet.

Part of the fee (30 €) covers NASS membership for the period of 2021–2023.

There will also be a conference dinner, to be paid for separately. We will provide information later on.


All talks will be schedule for 30 minutes, including Q&A discussion time, to be apportioned however you see fit. We particularly welcome conference presentations in the following research areas:

## The Complexity of Social-Cultural Emergence: Biosemiotics, Semiotics and Translation Studies



26-28 August 2021, KU Leuven, Belgium

Since the emergence of complexity thinking, scholars from the natural and social sciences as well as the humanities are renewing efforts to construct a unified framework that would unite all scholarly activity. The work of Terrence Deacon (2013), at the interface of (at least) physics, chemistry, biology, neurology, cognitive science, semiotics, anthropology and philosophy, is a great, though not the only, example of this kind of work. It is becoming clear that this paradigm of complex relational and process thinking means, among others, that the relationships between fields of study are more important than the differences between them. Deacon's contribution, for instance, lies not (only) in original findings in any of the fields in which he works but (also) in the ways in which he relates bodies of knowledge to one another. An example would be his links between a theory of work (physics) and a theory of information (cybernetics) by means of a theory of meaning (semiotics).

This line of thinking indeed situates semiotics and biosemiotics in the centre of the abovementioned debate (also see Hoffmeyer, 2008; Kauffman, 2012). In semiotics, Susan Petrilli's (2003) thought-provoking collection covers a wide variety of chapters focused on translation, which she conceptualizes as semiotic process. Her work made it possible to link biosemiotics and semiotics through the notion of "translation", which is what we aim to explore further in this conference. Michael Cronin's work in translation studies links up with the above through his use of the notion of "ecology". To apprehend interconnectedness and vulnerability in the age of the Anthropocene, his work challenges text-oriented and linear approaches while engaging in eco-translational thinking. He calls *tradosphere* all translation systems on the planet, all the ways in which information circulates between living and non-living organisms and is translated into a language or a code that can be processed or understood by the receiving entity (Cronin, 2017, p. 71). The aptness of Cronin's work on ecology finds a partner in that of Bruno Latour, whose development of a sociology of translation (2005) responds to the need to reconnect the social and natural worlds and to account for the multiple connections that make what he calls the 'social'.

In an effort further to work out the implications of this new way of thinking, Marais (2019, p. 120) conceptualized translation in terms of "negentropic semiotic work performed by the application of constraints on the semiotic process" (see also Kress 2013). Building on Peirce, namely that the meaning of a sign is its translation into another sign, translation is defined as a process that entails semiotic work done by constraining semiotic possibilities. This conceptualization allows for the study of all forms of meaning-making, i.e. translation, under a single conceptual framework, but it also allows for a unified ecological view for both the sciences and the humanities. "The long standing distinction between the human and social sciences and the natural and physical sciences is no longer tenable in a world where we cannot remain indifferent to the more than human" (Cronin, 2017, p. 3). These kind of approaches open ample possibilities for a dialogue between Translation Studies, Semiotics and Biosemiotics, exploring translation not only in linguistic and anthropocentric terms, but as a semiotic process that can take place in and between all (living) organisms - human and non-human organic and inorganic, material and immaterial alike. Not only the translation of *Hamlet* into French, or of oral speech into subtitles, but also communication between dolphins or between a dog and its master, or moving a statue from one place to another, or rewatching a film are translation processes. However, many of the implications of this line of thinking still need to be explored, and if the references to Deacon, Petrilli and Cronin holds, this should be done in an interdisciplinary way that tests, transgresses and transforms scholarly boundaries.

It is for this reason that we call for papers for a conference in which we hope to draw together biosemioticians, semioticians and translation studies scholars to discuss the interdisciplinary relations between these fields and the implications of these relations for the study of social and cultural reality as emerging from both matter and mind. We invite colleagues to submit either theoretical or data-driven or mixed proposals, reflecting on the complexity of social-cultural emergence as a translation process. Some of the topics that colleagues could consider would be the following:

- Is translation, as semiotic work and process, indeed able to link all of the biological world, including humans, with the non-living world in one ecology, and if so how?
- What conceptual constructs in each of the three fields are relevant for the other fields, and how?
- Could the fields learn methodological and epistemological lessons from one another? If so, what would these entail?
- Could collaborative scholarship enhance an understanding of social-cultural emergence, and if so, what would this scholarship entail?
- How, if at all, does entropy and negentropy play out differently in social-cultural systems compared to biological and/or physical systems?
- How does social-cultural emergence differ from biological and even physical emergence? Systems thinking tends to ignore differences like the intentionality of biological agents in contrast to physical agents. Thus, if one were to consider the possibility that intention has causal effect, how does one factor intention into thinking about complex adaptive systems?

**NB:** Given the uncertainty surrounding the impact of the Covid-19 pandemic, the conference will probably be online or a hybrid of online and face-to-face interactions.

The 4-day congress will take place on **25–26 February at Tallinn University** and on **27–28 February at the University of Tartu**, Estonia.



On 21, 22 and 23 April 2022, the University of Granada will host the XIX International Congress of the Spanish Association of Semiotics with the aim of reflecting on the three concepts of the title of the Congress: body, subject and semiotic reflection. 

#### Neuroscience and Translation

#### Author: MARIA TYMOCZKO



Many of the basics of the neuroscience of perception, memory, plasticity, attention, decisions, choices, and control have achieved consensus. Accordingly, it is now possible to use this research to investigate the implications for cognition and behavior associated with language, multilingualism, and translation, as well as related phenomena such as semiosis and cross-cultural communication. (P. 12) We are "born to choose". Belief in one's ability to exert control over the environment through choice is essential to well-being. People desire both choice and control. Translation is an activity that instrumentalizes these functions. (P. 357)

Maria Tymoczko is Professor of Comparative Literature at the University of Massachusetts Amherst. She holds three degrees from Harvard University, where she studied the topics discussed in her research and

publications: the sciences, medieval languages and literatures, and topics related to translation theory and practice. Her books include *The Irish "Ulysses"* (University of California Press, 1994), *Translation in a Postcolonial Context* (St. Jerome Publishing, 1999), *Enlarging Translation, Empowering Translators* (St. Jerome Publishing, 2007), and several edited volumes on translation research. 
#### The Material Bases of Meaning

Author: GIORGIO PRODI

#### Foreword by Kalevi Kull and Felice Cimatti; afterword by Anna Gasperi-Campani

Contemporary semiotics has often gone too far in proposing language as the model to explain every phenomenon of communication. Giorgio Prodi's seminal book, originally published in Italian in 1977, poses the question from the opposite perspective: his 'natural history of meaning' does not depict a biological universe that behaves as if it spoke, but a cultural universe structured even at its highest levels according to the same modes and processes of mutual adaptation and 'reading' that happen at the level of cells.

The picture he paints shows us knowledge at its origin, as a process of environmental adaptation and interpretation, in which the discoveries of biology interact with those of semiotics. Within this natural history of language competence, the book emphasises the remote, primitive phase, which takes place below the threshold of the subjective and the social. Proceeding from there it outlines a holistic hypothesis of semiosis at the cultural level: the elementary phases of the recognition of meaning, which



become progressively more complex as the phylogenesis progresses, lead all the way to the construction of linguistic systems in the human animal.

#### (Re)considering Roman Jakobson

#### Editors: Elin Sütiste; Remo Gramigna; Jonathan Griffin; Silvi Salupere



This book was initiated by a graduate course on the semiotics of Roman Jakobson (1896–1982), taught by Elin Sütiste at the Department of Semiotics, University of Tartu. The contributions include articles by participants in the course as well as visiting scholars and colleagues at the University. The seminars affirmed that Jakobson was truly an ambitious, forward-thinking scholar who exerted himself to establish semiotics as a discipline. Although Jakobson identified himself as a philologist, he played a pivotal role in the development and institutionalization of semiotics.

Jakobson's ability to grasp the potential of new ideas and to inspire others was remarkable. Juri Lotman commented on this, "Wherever his fate of a mid-20th-century man took him, every where Jakobson attracted a

group of scientists that soon grew into a scientific centre of global importance". The volume explores specific points of relevance to contemporary semiotics found in Jakobson's work, while each of the 13 essays approaches the issues from a different angle.

## The Meaning of the Built Environment: A Semiotic and Geographical Approach to Monuments in the Post-Soviet Era

#### Author: FEDERICO BELLENTANI

This volume analyses the interpretation of the built environment by connecting analytical frames developed in the fields of semiotics and geography. It focuses on specific components of the built environment: monuments and memorials, as it is easily recognisable that they are erected to promote specific meanings in the public space. The volume concentrates on monuments and memorials in post-Soviet countries in Eastern Europe, with a focus on Estonia. Elites in post-Soviet countries have often used monuments to shape meanings reflecting the needs of post-Soviet culture and society. However, individuals can interpret monuments in ways that are



different from those envisioned by their designers. In Estonia, the relocation and removal of Soviet monuments and the erection of new ones has often created political divisions and resulted in civil disorder. This book examines the potential gap between the designers' expectations and the users' interpretations of monuments and memorials. The main argument is that connecting semiotics and geography can provide an innovative framework to understand how monuments convey meanings and how these are variously interpreted at societal levels.

- administering the reviewing process: scheduling it with a close-in review-completion date, maintaining contact with reviewers (sending them reminders), ensuring review integrity, receiving and copy-editing reviews as needed, conforming them to the SSA stylesheet, and inserting them in the journal's production workflow.

The Book Review Editor receives no remuneration but gets a chance to work with wonderful scholars from everywhere, and to learn a great deal while remaining up-to-date on the latest scholarship. This position is appointed by the SSA Executive Director and reports to the journal's Editor-in-Chief. Expected hours of work per month is approximately 10, though highly variable.
