## Venue: Sibelius Academy of the Uniarts Helsinki

The 13th conference of the Nordic Association for Semiotic Studies focuses on the epistemologies and ontologies of signs and minds and how the processes of signification entail different aspects of feeling, skill, and knowledge. Connecting to the systemic relationality of the subject and the world, these viewpoints on doing and being, discourse and development have been at the heart of semiotics through the diachrony in various contexts. Now, in the rapidly, even brutally changing world, understanding signs, signification and their dynamics seems more crucial than ever, as it may affect securing how the human and their practices, their social systems and societies, cultures and the environment may flourish in whatever way the future will unfold.

The conference focuses on how theories and research into meaning and signification address knowledge, skill, and feeling. We warmly welcome theoretical and empirical papers investigating the relations of this trio or any of the three concepts that are central to semiosis.



# Report from the 15th World Congress of Semiotics (IASS-AIS)

## Semiotics in the Lifeworld

#### August 30 - September 3, 2022 - Thessaloniki, Greece

Under the auspices of the IASS/AIS, University of Macedonia, together with the Hellenic Semiotic Society, and the Laboratory of Semiotics, Aristotle University of Thessaloniki, organized the 15th World Congress of Semiotics, which took place in Thessaloniki, Greece, from August 30 to September 3, 2022.

The congress was devoted to the comprehensive, albeit initially ambivalent concept of *Lifeworld* (or better - *the world of lived experiences*). Lifeworld is usually activated in times of crisis when, in Husserlian terms, "Europe is sick". In such situations, in order to recover significance of life, attention is turned again to the human world, as it is pre-given: to its pre-scientific self-understanding and unquestionability.

Lifeworld, or its original variant Lebenswelt, belongs among the basic concepts of the modern vocabulary of the 19th and 20th centuries. Most of its variations are compounds with the root "World"/Welt/, i.e., Bildwelt, Gedankenwelt, or are formed as the anthropologization of the "world" - Weltschmerz, Weltseele, Weltsprache, Welthorizont. The mission of such concepts is to maximally expand or focus the range of meanings of the concept, thus covering all partial experiences of human existence.

The term Lebenswelt /Lifeworld/ appeared in the first half of the 19th century, namely, in Heinrich Heine's 1836 short story "Florentine Nights" in the context of the struggle between light and darkness characteristic of Romanticism - "sonnige Lebenswelt" /sunny Lifeworld/. In the sciences, the concept began its ascendance precisely a hundred years later with Edmund Husserl's "The Crisis of European Sciences and Transcendental Phenomenology"<sup>1</sup> [1936], which contextualized the radical crisis in Europe as the result of the positivist limitation of science.

This was followed by works of Heidegger, Gadamer, various post-structuralist (Deleuze, Derrida) and post-metaphysical constructive theories (Habermas), all of which have some

semiotic connotations, which though never play the first role. Unfortunately, we have not yet recognized the semiotic qualities, which can be found in Edmund Husserl's early works, in which he also discussed the nature of signs. True, they have sunk into a certain oblivion, which, unfortunately, was not rectified by the 2022 World Congress in Semiotics which had the umbrella title "Semiotics in the Lifeworld". Tellingly, Husserl's "On the Logic of Signs /Semiotics/" (1890) was not the subject of any of the congress's sections.

This is probably because, at the Thessaloniki Congress, descriptive semiotics and several aspects of the application of semiotics were generally dominant. Theoretical semiotics and solutions to methodological issues were marginal this time: the presentations of all eleven keynote speakers focused on one or another aspect of the Lifeworld rather than on the lifeworld itself as the theoretical foundation for all human semiosis. These more specific and restricted studies can be described as approaching the Lifeworld – e.g., in terms of fashion, food, spectacle, design, places, and, of course, Covid 19.

At the World Congress, theoretical aspects of semiotics were addressed by existential semiotics, Peirce's and Greimas' semiotics, and attempts to connect to the writings by Ludwig Wittgenstein, which have been left somewhat marginalized, as well as the writings by Bruno Latour. The boundary situation between theoretical and applied semiotics was illuminated by biosemiotics in its broadest sense – starting with the study of yet undiscovered forms of life, to the context of unity and monovalence of life, musical signification, and semiotics of color. In general, the congress can be considered a success because it explored forgetting that takes place within Lifeworld in a wide semiotic spectrum.





## **Call for Papers**

Umwelt analysis, initially proposed by Jakob von Uexküll, revolutionised studies on animal behaviour and perception by targeting them as semiotic phenomena, that is, based on meanings and signs. In the Institute of Umwelt research in Hamburg, of which Uexküll was the director, umwelt theory served as a shared theoretical ground for research on topics as diverse as the umwelten of fighting fish to the training methods of guide dogs. In the 21<sup>st</sup> century, the scope of umwelt theory has vastly expanded, both in terms of disciplines – from anthropology to ecology – and the phenomena that are addressed with the help of the theory. Novel theoretical connections and disciplinary embeddings, as well as new

changes in the lifeworld itself, bring along new challenges and questions: how to fit umwelt theory with existing methodologies and theoretical backgrounds of various other disciplines, how to make it a working analytical tool in the context of human-induced environmental change, and what are the methodologies that have been developed since the times of Uexküll which would help to carry out empirical analyses of animal umwelten today.

To scrutinize these questions, the Department of Semiotics at the University of Tartu will organize the conference Contemporary Umwelt Analysis: Applications for Culture and Ecological Relations between 18-19 April, 2023. We will especially look for contributions in the following topics:

- Umwelt analysis across disciplines (ecology, anthropology, literary studies, economics, etc.).
- Umwelt analysis in different applications, methods, and fieldwork.
- Human and animal umwelten in the era of anthropogenic environmental change.
- Contemporary developments in umwelt thinking.

## **Call for Papers**

Fear plays an important role in human culture on the individual as well as on the collective level serving as one of the constraints that regulates people's choices and behaviour. However, at times the mechanism of fear seems to spiral out of control, and fear spreads like an epidemic infecting meaning-making processes in various areas of culture. According to Juri Lotman (1922–1993), renowned Russian-Estonian semiotician, literary scholar, and cultural historian, in such epidemics, the experience of fear is not caused by any concrete danger; instead, fear is in search for an object and constructs its own threat. Estonian semiotician and literary scholar Mihhail Lotman has developed his father's ideas further and proposed that from the perspective of semiotics it is important to distinguish between fright and fear. According to him, the former signifies an immediate reaction to events that have already taken place, it is a natural response to a specific stimulus, not a result of an interpretation. The latter, however, occurs as anticipation of danger projected into the future and is based on sign processes that generate the experience of fear. In the present times, the anticipated future is inhabited by many fears evoked by constant geopolitical insecurities, climate change, ideological polarisation, economic uncertainty, the spread of misinformation and viral disease. Therefore, an interdisciplinary dialogue is necessary to create a better understanding of the role fear plays in these various processes in culture. The 13th Annual Lotman Conference at Tallinn University aims to bring together discussions about fear from various disciplines. We invite theoretical explorations, historical inquiries and concrete case studies that would help to illuminate the phenomenon of fear from various perspectives and together provide a multifaceted understanding of the complex workings of fear in culture.

The topics of interest include but are not limited to:

- Semiotic mechanisms of fear
- Fear in the collective memory
- History of fear
- Representations of fear in artistic texts
- Media and dissemination of fear
- Fear and the digital culture
- Fear and the environment
- The politics and economics of fear
- Fear and conspiracy theories
- Fear, hate and violence
- Fear and indeterminacy
- Cultural psychology of fear
- Philosophy of fear
- Fear in folklore
- Fear and religious beliefs

The congress will take place on **15–17 June at Tallinn University**, **Estonia**. The official languages of the congress are English and Russian. All participants are expected to be present on-site, as the conference will not have the option of distant participation.

Digital Transformation of Education: Semiotic and Interdisciplinary Perspectives

The advent of the Internet and digital technologies in general has wrought deep changes to the socio-cultural tissue in almost every part of the world and societies. At the same time literacy might be seen as the ability to read, write, speak and listen in a way that lets us communicate effectively and make sense of the world. In other words literacy is the standardized and systematic way to introduce individuals to a full extent in the world of semiosis and signification. Thus comes the question: is there today any other form of literacy except the digital literacy? The question obviously does not concern those who have already acquired their literacy before the digital age. The question concerns those who are involved in education – the universal provider of literacy: the internet born generations and us – the professionals in the system of education.

Editors expect semiotic and interdisciplinary contributions at least in three directions of thought and any other proposal under the general title is welcome:

Education and digital citizenship: on the one hand there are obvious advantages for the efficacy of the democratic processes, transparency and connectedness of every single citizen. On the other hand, the power of social media changes the rules of the political game, giving rise to the opposite of democracy: wild digital populism, legitimizing racist, xenophobic and homophobic ideas reaching political representation; social destabilization of entire countries through hybrid wars of misinformation, cyber attacks of institutions and sabotage of elections. The immune system of democracies will more and more depend on the higher education of digital citizenship.

How new digital technologies like VR, AR, interactive platforms, social media, search engines change the very process and outcomes of education at all levels. About the proliferation of alternative commercial forms of education services, competing with the institutional ones, but better adapted to the new standards of communication and digital interactivity.

experienced, embodied and often polysemiotic in nature.



## HORTUS SEMIOTICUS THEMATIC ISSUE: "POP CULTURE, MEDIA AND TRANSMEDIALITY"

#### Editors: Eleni Alexandri and Andrew Mark Creighton



Hortus Semioticus is an independent journal run by students at the Semiotics Department of Tartu University. This special issue focuses on pop culture, media, and transmediality, creating a platform for young academics to approach a variety of topics following these primary themes.

Tamara Ovchinnikova examines the intersemiotic translation of Sherlock Holmes, as the characters jump from the original text's pages to our screens in the BBC series, Sherlock. Irma Susana Carbajal Vaca and Hugo David Tiscareño Talaver use applied semiotics to propose a new methodological framework to enrich and expand violin's

classical formal education. In her article, Samantha Herrerías, scrutinises the positive and negative aspects of remediating the past, with an analysis of Narcos: Mexico, while Andrew Mark Creighton analyses fan productions in the context of McDonalization, convergence culture, and implosion, showcasing how leisure has been equated with labour in the virtual environment. Eleni Vatala studies the semiotic space of the video game Beholder as another semiosphere with specific boundaries and multiple textual levels, while Heidi Campana Piva presents a thorough historical literature review to emphasise the necessity for creating a new methodological framework fitting for the analysis of the participatory and cyber-culture of today's world. Last but not least, Jorge Flores' article examines the multimedial narrative of Ong's Hat, the group of scientists that allegedly traversed across dimensions, as an exemplary case study regarding media and transmediality.

Along with the academic articles, this edition includes an interview with Rhea Colaso, master's graduate of semiotics, and Mohar Kalra, American artist and visiting researcher at Tartu University. They both share their experiences with semiotics, and explain how it can be applied outside academia.
